This fund update was first made publicly available on 29 October 2021.

What is the purpose of this update?

This document tells you how the Russell LifePoints® Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

Description of this fund

The Russell LifePoints® Growth Fund aims to produce returns well in excess of inflation by investing mostly in growth assets with only a modest allocation to income assets.

What are the risks of investing?

Risk indicator for the Russell LifePoints® Growth Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

* The annual membership fee was reduced to \$39.96 from 1 February 2021. Prior to this date the annual membership fee was \$49.80, or \$40 if you were under 18.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$1,641 (that's 16.41% of his initial \$10,000). Jacob also paid \$39.96 in membership fees. This gives Jacob a total return of \$1,601.04 for the year.

What does the fund invest in?


Actual investment mix

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in.

The targeted level of currency hedging for international equities is 50%. Other global asset classes target a 100% hedge to the New Zealand dollar. As at 30 September 2021 the fund's unhedged foreign currency exposure was 25% of the net asset value of the fund.
