What is the purpose of this update?

This document tells you how the Russell LifePoints® Target Date 2015 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

Description of this fund

The Russell LifePoints® Target Date 2015 Fund aims to produce returns in excess of inflation by investing mostly in income assets with only a modest allocation to growth assets. This fund is closed to new investors.

What are the risks of investing?

Risk indicator for the Russell LifePoints® Target Date 2015 Fund.

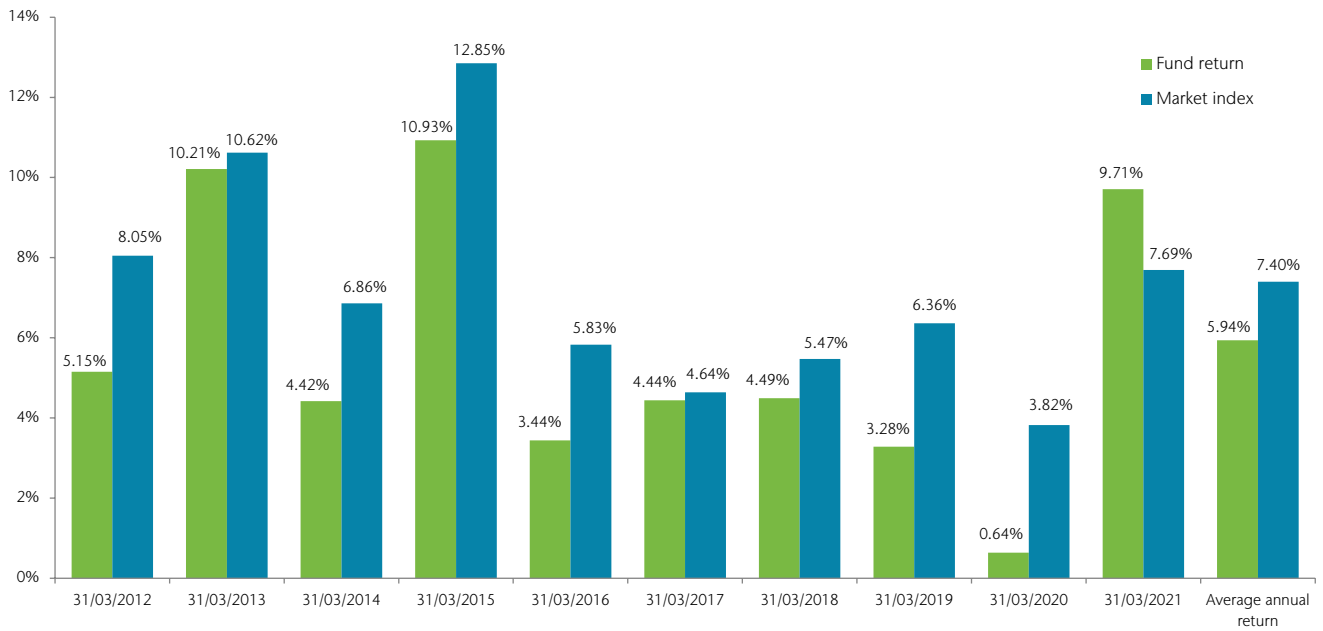
How has the fund performed?

* The annual membership fee was reduced to \$39.96 from 1 February 2021. Prior to this date the annual membership fee was \$49.80, or \$40 if you were under 18.

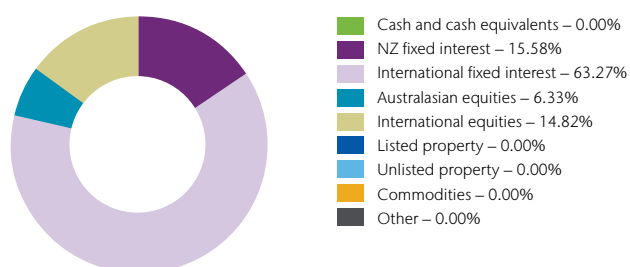
Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$366 (that's 3.66% of his initial \$10,000). Jacob also paid \$39.96 in membership fees. This gives Jacob a total return of \$326.04 for the year.

What does the fund invest in?

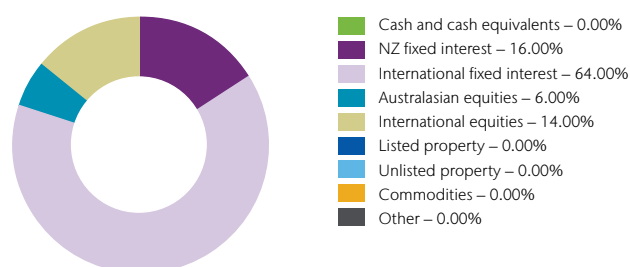
Actual investment mix

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in.

The targeted level of currency hedging for international equities is 50%. Other global asset classes target a 100% hedge to the New Zealand dollar. As at 30 September 2021 the fund's unhedged foreign currency exposure was 7% of the net asset value of the fund.
